This Indenture made this Seventh day of December and in the year of our Lord
 one thousand Seven hundred and Seventy nine Between John Barrett and Cherry his wife
 of Virginia and County of Southampton of the one part and Nathan Britt Junr
 of the county aforesaid of the other part witnesseth that the said John Barrett and Cherry
 his wife for and in Consideration of the Sum of ten pounds to them in hand paid
 at or before the sealing and delivery hereof the receipt whereof is hereby acknowledged
 hath granted bargain and by these presents fully and absolutely grant bargain
 sell enfeoff Release and Confirm unto the said Nathan Britt Junr one certain tract
 or parcel of land lying and being in the aforesaid county of Southampton
 containing sixteen acres more or less and bounded as followeth beginning at
 a pine a corner of Thomas Everetts and Nathan Britt Junr then along the
 said Britt line near west to the road called the Pitch Road then along the said
 Road to Robert Gilliams line then along the said Gilliams line to Thomas
 Everetts line then along the said Everetts line to the beginning Together with all
 houses out houses Edifices buildings woods waters water Courses profits Common
 dities hereditaments and appurtenances whatsoever to the said tract or par-
 -cel of land and premis belonging or in any wise appertaining and the
 Reversion and Reversions Remainder and Remainders Rents issues and profits
 thereof and all the estate Right title and Interest if them the said John Barrett
 and Cherry his wife their heirs and assigns To have and to hold the
 the said tract or parcel of land and premises with the appurtenances herein
 before mentioned unto the said Nathan Britt Junr his his heirs and assigns
 forever to the only proper use and behoof of him the said Nathan Britt
 Junr his heirs Executors Administrators and assigns forever and the
 said John Barrett and Cherry his wife for themselves their heirs and by
 these presents Covenant and agree that the above granted premises
 are free and clear of all Charges and incumbrances whatsoever and shall
 and will warrant and defend the same unto the said Nathan Britt Junr
 and to his heirs executors & administrators from them the said John Britt
 and Cherry his wife and from all and every other person or persons whatsoever
 in witness whereof the said John Britt & Cherry his wife have hereunto
 set their hands and Seals the day and year above written
