

To all To whom these presents shall come I Peter Butts do send greeting know ye that I the said Peter Butts of the parish of Nottoway in the County of Southampton for and in consideration of the love good will and affection which I have and do bear towards my son Benjamin Butts of the parish Saint Luke & County of Southampton have give and granted and by these presents do fully clearly and absolutely give and grant unto the said Benjamin Butts his heirs and assigns Executors or administrators one certain tract or parcel of land containing five hundred and fifteen acres ^{to the same} more or less lying and being in the County of Southampton & on the South side of Nottoway River it being being the same whereon he now liveth together with the Slaves following to wit Sam Hannah Hodges Pegg Doll Lett Frank & Sue To have and to hold all the aforesaid land and Slaves to him the said Benjamin Butts and his heirs or assigns forever from henceforth as his or their absolute property without any manner of conditions in witness whereof I have herunto set my hand and seal this Sixth day of September in the 4th year of this Commonwealth by the grace of god in the year of our lord god 1779

and fifty Acres and bounded according to the most known antient and reputed
bounds thereof together with all houses out houses woods ways waters profits com-
modities hereditaments and appurtenances and the reversion and Reversions

demand of the said Jacob Wheeler and Sarah his wife of in and to the said
and every part thereof To have and to hold the said tract of land with all
