This Indenture made this the tenth day of January in the Year
our Lord Christ in thousand seven hundred ninety and one between Solomon
Worrell and Rebecca Worrell his wife of the County of Southampton & parish
of Wotton of the one part and Micajah Griffin of the County and parish
aforesaid of the other part witnesseth that for and in consideration of
the sum of thirty pounds current money of Virginia by the said Micajah
Griffin to him in hand paid at or before signing and delivery of this
present the receipt whereof the said Solomon Worrell and Rebecca
Worrell his wife doth hereby acknowledge and herof acquit and
discharge the said Micajah Griffin his heirs and assigns forever by these
present the said Solomon Worrell and Rebecca Worrell his wife
hath granted Bargained sold Aliened released and confirmed and by
these presents doth grant Bargain sell set over alien released confirm
unto the said Micajah Griffin his heirs and assigns forever all that plantation
Mesuag tract or parcel of land Being the land that John Johnson gave
to his son James Johnson the said land containing by estimation then or here
after 57 acres and bounded as followeth beginning at a pine a corner joining
James Vicks land thence a long the said Vicks line to the Cypress swamp
down the said Cypress Swamp to a oak a corner of Solomon Worrells land
and thence a long a line of marked trees to the beginning of all houses out
houses edifices buildings yards gardens orchards trees ways waters water
courses profits Commodities hereditaments and appertinances to the said
tract of parcel of Land belonging or in any wise appertaining and the
Reversions Reversions Remainder and Remainders rents Offices and profits
thereof and all the Estate right title Interest use Post interest possession
property claim and demand whatsoever of the said Solomon Worrell &
Rebecca Worrell of in and to the same and every part thereof and all deeds
evidences writings touching or in any wise concerning the same To have
and to hold the said plantation tract or parcel of Land and premises
with the appertinances unto the said Micajah Griffin his heirs & assigns
forever and the said Solomon Worrell and wife Rebecca Worrell for
their felws their heirs and assigns doth hereby covenant promise and grant
to and with the said Micajah Griffin his heirs & assigns by these presents
that the said Solomon Worrell and wife Rebecca Worrell hath hereby
granted unto the said Micajah Griffin his heirs and assigns forever
against title claim or demand of any person or persons whatsoever
