This Indenture made this eleventh day of August in the year of our Lord one thousand seven hundred and ninety Between James Vick Jr of the County of Southampton and parish of Notaway of the one part and Jordan and Joseph Denson of the County and Parish aforesaid of the other part witnesseth that the said James Vick for and in Consideration of the just and full sum of forty one pounds Current money of Virginia by the said Jordan and Joseph Denson to him in hand paid before the sealing and delivery of these presents the receipt whereof the said James Vick doth hereby acknowledge and thereof acquittance discharge the said Jordan and Joseph Denson their heirs and assigns forever and himself therewith fully and entirely satisfied Contented and paid he the said James Vick hath granted bargained sold aliened or feoffed released set over delivered & confirmed and by these presents doth Grant bargain sell also or feoff release set over deliver and Confirm unto the said Jordan and Joseph Denson and to their heirs & assigns forever all that plantation Mefuge tract and parcel of land wherein the said James Vick now lives situate lying and being, in the County of Southampton and parish of Notaway aforesaid Containing by estimation one hundred and seventy acres be the same more or less and being part of a three hundred & twenty acres of land granted to Joseph Vick by letter patent bearing date the 23rd of Feb^r 1793 and by him conveyed to his son James Vick Jr who conveyed the same to his son the aforesaid James Vick Jr and being bounded as follows (to wit) beginning in the patent line on Notaway swamp thence said line to a small branch which divides the said lands from the lands which the said James Vick sold to John Francis then down the run of the said branch to Notaway Swamp and down the run of the said swamp to the big inling and all the houses out houses edifices buildings woods ways waters and water courses gardens orchards mead ays flocks law grounds profits Commodities hereditaments and appurtenances whatsoever to the same belonging or in any wise appertaining and therevise and revisions remainder and remainders rents Ifues and profits thereof & all the estate right title interest Claim and demand of him the said James Vick or any to the same and every part and parcel thereof to have and to Hold the said plantation Mefuge tract and parcel of no hundred and seventy acres of Land with all and every the appurtenances as aforesaid unto them the said Jordan & Joseph Denson and to their heirs and assigns for ever to the only proper use and behoof of them the said Jordan and Joseph Denson and to their heirs and assigns forever and the said James Vick for him self his heirs and assigns
