receipt whereof the said Benjamin Kirby and Ann his doch her chy ach
and thereof and there upon doth acquit and discharge the said Miles Kirby
his heirs and assigns forever and themselves therewith fully and intirely
satisfied Contented and paid they the said Benj^e Kirby and Ann his wife
have granted bargained sold aliened enfeoffed released set over delivered
and confirmed and by these presents doth grant bargain sell alien
enfeoff release set over deliver and confirm unto the said Miles Kirby
and to his heirs and assigns forever one certain Tract and parcel of
land situate lying and being in the County of Southampton aforesaid
and lying between the Appamoseck swamp and the Curumha Swamp
Containing one hundred acres more or less and so indeed as follow

swamp then up the run of the said Swamp forty four poles to a
