This Indenture made the Twentieth fifth day of the month of June  
 one thousand and six hundred and thirty two between the said John Rogers of Southampton County for the  
 one part and the said Thomas Turner of the same County of the other part Witnesseth that  
 the said Thomas Turner the receipt whereof of the said  
 John Rogers hath hereby acknowledged hath granted bargained sold aliened  
 confirmed and by these presents do grant bargain sell alien and confirm unto  
 the said Thomas Turner his heirs and assigns forever one certain tract or parcel  
 of land containing thirty acres be the same more or less lying and being in  
 Southampton County the North side of Mecharing River being part of the  
 tract of land whereon said Rogers lives bounded as followeth to wits Beginning  
 at a maple in a small branch thence along Rogers line to a light wood stump  
 a corner mentioned in Turners old patent thence a south course along the old  
 dividing line between Thomas Turners and said Rogers to a corner lying by  
 the side of the bottom thence along said Turners and Rogers line to the head  
 of a Branch thence down said Branch which formerly divided line between  
 Turner and Rogers to the main Run of the said Branch thence up the run  
 of said Branch to a white oak by the side of an old path thence along  
 a new dividing line of mark Trees to the Beginning or first station to have  
 and to hold the said Tract or parcel of land with the appurtenances unto  
 the said Thomas Turner his heirs and assigns together with all profits com-  
 munities advantages Here stipulations whatsoever and also the reversion and  
 reversions remainder and Remainders rents and services of the said land and  
 premises and every part thereof and also all the estate right title interest  
 claim and demand whatsoever of the said John Rogers his heirs executors &c.  
 of and to the said land and premises above mentioned and every part  
 thereof with the appurtenances unto the said Thomas Turner his heirs and  
 assigns to the only proper use and behoof of the said Thomas Turner  
 his heirs and assigns forever and the said John Rogers for himself his  
 heirs the said land and premises and every part and parcel thereof  
 against me my heirs and against all and every other person or Persons  
 whatsoever claiming or pretending to claim any right title or interest  
 to the said land above mentioned shall and well warrant and forever  
 defend by these presents in such of which of the said John Rogers  
 hath set his hand and affixed his Seal the day and year above written
