

This Indenture made this ninth day of February in the year of  
 to  
 B.C. Lord one thousand seven hundred and ninety two Between Hardy Johnson and  
 Rebecca his wife of the Parish of Holloway in Southampton County Virginia of the  
 age of one part and Etheldred Drake of the parish and County aforesaid of the other part  
 witnesseth that we the said Hardy Johnson and Rebeckah his wife for and in consider-  
 ation of the sum of twenty pounds current money of Virginia to them in hand paid by  
 the aforesaid Etheldred Drake before the sealing and delivery of these presents therescip-  
 matic hereof the said Hardy Johnson and Rebeckah his wife doth acknowledge and  
 AB 866 of every part and parcel thereof doth truly clearly acquit Etheldred Drake and discharg-  
 eth aforesaid Etheldred Drake his heirs Executors administrators and every of  
 them aforesaid for divers good causes then unto moving hath granted bargained  
 sold made over and by these presents doth bargain sell and forever make over and con-  
 firm unto the aforesaid Etheldred Drake and certain messengers trust and parcel  
 of land lying and being in the parish and County aforesaid and bounded as followeth  
 beginning at a sweet gum tree joining Gion Williams and Amos Councils land thence down  
 the south prong of the Cypre of swamp to a white oak a corner tree thence along a line  
 of marsh trees joining Hardy Johnsons land to a pine a corner tree thence along  
 a line joining Amos Councils land to the first Station Containing by estimation  
 fifty acres to the same more or less with all dwelling houses and out houses  
 gardens orchards pastures and pasture grounds woods and under woods timber  
 swamps and bog grounds springs and fountains with all liberties and privileges  
 as well as mentioned as intended to have and to hold the aforesaid tract and parcel  
 of land and we the said Hardy Johnson and Rebeckah his wife doth covenant  
 agree to and with the aforesaid Etheldred Drake that he no withdrawingly proper  
 owner of the aforesaid demised land and premises and that we hath in our selves a good  
 right and lawfull authority in our simple to bargain and sell the same and will and  
 doth warrant their right where to the Etheldred Drake and his heirs Executors admis-  
 sion forever clear from the just claim or claims of any and all manner of persons whatsoever  
 that may or shall at any time or times hereafter lay or pretend to lay any manner  
 of just claim or claims right title or interest to the aforesaid land and premises  
 or any part thereof belonging and that the said Etheldred Drake shall from  
 time to time and at all times hereafter peaceably and quietly have hold  
 occupy possess and enjoy the same forever without any interruption or molestation  
 of them the said Hardy Johnson and Rebeckah his wife or any other person  
 claiming from by or under them the said Hardy Johnson and Rebeckah  
 his wife is now from this time hence forward over hereafter fully  
 clearly and absolutely acquitted exonerated and discharged of and  
 from the aforesaid fifty acres of land or any part thereof belonging in your  
 witness hereof we the said Hardy Johnson and Rebeckah his wife  
 have hereunto set our hands and seals the day & year
