This Indenture made this first day of June in the year of our Lord one thousand seven hundred and ninety three. Between Thomas Joyner & Martha his wife of the county of Southampton & parish of Nettonway of the one part & Joseph Denson of the county & parish aforesd of the other part witnesseth that the sd Thomas Joyner & Martha his wife for an & inconsideration of the just & full sum of six pounds current money of the King by this sd Joseph Denson to them in hand paid before the writing & delivery of these presents the receipt whereof the sd Thomas Joyner & Martha his wife doth hereby acknowledge & thereof acquit & discharge the sd Joseph Denson his heirs & assigns forever and themselves therein with fully & actually satisfied contented & paid they the sd Thomas Joyner & Martha his wife hath granted bargained sold aliened enfeoff released & conveyed delivered & confirmed & by these presents doth grant bargain sell alien enfeoff release & convey over deliver & confirm unto him the sd Joseph Denson & to his heirs & assigns forever all that messuages tract & parcel of land situate lying & being in the county of Southampton & parish of Nettonway aforesd containing by estimation twenty five acres of land be the same more or less & bounded as follows (to wit) Beginning at a sweet gum a corner tree between Joseph Denson & Henry Jones thence along a line of marked trees to a black gum standing in a small branch thence down the run of the sd branch to a black gum standing in the long grounds of the cattail branch which is to be a corner between the sd Thomas Joyner & the sd Joseph Denson thence a straight line of newly marked trees through the head of the sd cattail branch to a maple standing in James Clarke's line thence along the sd Clarke line down the various courses of the sd cattail branch to Presley Barrett's line thence along the sd Barrett's line to the sd Joseph Denson thence along the sd Denson's old line to the beginning containing twenty five acres be the same more or less
