

This Indenture made the 12 day of Feb 1793 Between Jacob Bailey & Amy his wife of the County of Southampton and State of Vir^g of the one part & Robert Daughtry of the same County & State of the other part (Witnesseth) that the said Jacob Bailey & Amy his wife for in consideration of the sum of Thirty Three pounds three Shillings & Six pence half Penny Value of these presents the receipt whereof the said Jacob Bailey & Amy his wife doth hereby acknowledge & thereupon acquit & discharge the said Robert Daughtry his heirs & assigns forever by these presents they the said Jacob Bailey & Amy his wife have granted bargain & sold alien & Released & confirmed and by these presents do grant sell Alien Release & confirm unto the said Robert Daughtry and his heirs & assigns forever a tract or parcel of land lying & being on the South side of Nottingham River in the County aforesaid containing Thirty Nine & three quarter Acres and bounded as followeth (To wit) Beginning at poplar in the side of a small branch thence Southwesterly 61 Pole to Hickory thence Easterly 79 Pole to a Maple in the side of a small branch thence Northwesterly 64 Pole to a Gum in the side of a small branch thence over the branch 20 paces to a lightwood Post in W^m Edwards line thence Westerly a long Edwards line to a white oak in the side of a small branch thence down the run of the said branch to the beginning with all woods underwoods Trees ways water & water courses low grounds one a down profits Commodities & appurtenances whatsoever belonging to the said tract or parcel of land & premises belonging or in any way appertaining To have and to hold the said tract or parcel of land and premises to the only proper use & behoof of the said Robert Daughtry his heirs or assigns forever & the s^r Jacob Bailey & Amy his wife for themselves their heirs & assigns forever & to them & to their heirs & assigns forever in manner & form following that is to say that the s^r Robert Daughtry his heirs and assigns shall & may at all times forever hereafter peaceably have hold & occupy possess all & singular the said thirty nine & three quarter Acres of land & premises as above mentioned with the appurtenances without the least trouble hindrance molestances or disturbance of all & every Person or persons whatsoever & further that the s^r Jacob Bailey & Amy his wife & all persons claiming or to claim by force or under them anything in the premises above mentioned or in any part thereof shall & will from time to time & at all times hereafter upon the reasonable request & at the costs & charge of the s^r Robert Daughtry his heirs & assigns make do & execute or cause to be done or executed & every such further & better lawful & reasonable act & acts thing & things devise & conveyances in the law whatsoever for the further better & more perfect granted conveying & enjoying of all & singular the premises above mentioned with the appurtenances unto the said Robert Daughtry his heirs & assigns as by the s^r Jacob Bailey his heirs & assigns or his or their council learned in the Law shall be lawfully & advised and devised or required - And Lastly that the said Jacob Bailey & Amy his wife & their heirs the above granted premises & every part & parcel thereof unto the said Robert Daughtry his heirs and assigns against the lawful claim title & demands of all & every Person & Person what soever shall and will warrant & never defend by these presents & the Witnes whereof the said Jacob Bailey & Amy his wife hath to these presents at their hands & seals this day & year above written Signed Sealed & delivered in presence of
