This Indenture made this 17th day of July in the year of our Lord 1793 Between Arthur Whitehead & Sally Whitehead his wife of Stan county & State of Virg^a of the one part & Samuel Maget of the county & State aforesaid of the other part Witnesseth that the said Arthur Whitehead & Sally his wife for and in consideration of the sum of Thirty Pounds current money to them in hand paid by the said Sam^l Maget there receipt whereof we do hereby acknowledge have granted sold & conveyed & confirm & by these presents do grant bargain sell & convey unto this said Sam^l Maget his heirs & assigns forever Twenty five acres of Land more or less lying & being in the apt^s County of Sta^t in the fourth side of Mattoway River on the south of the Cypress & Cabin Swamp its boundaries as follows Beginning at a small post oak a corner tree between Nicholas Maget the apt^s with Whitehead then running near a west course along a line of mark is trees to a pine standing in a small branch then up the said branch to a post oak standing in the head of branch then running near a west course along a line of mark is trees to a black oak a corner between Rich Maget line then down the said line to a small post oak a corner tree then along the said line to the Beginning And also the reversion & Residues Remainders & Remainders Rents & Services of the said land & Premises & every part & parcel thereof To have and to hold all & singular the said Land within mention is & every part & parcel thereof with the appurtenances to the said Sam^l Maget his heirs & assigns forever for the said Arthur Whitehead & Sally his wife for ourselves our heirs & assigns the said land & Premises & every part thereof against
