and William Harcom of the said county of the other part Witnesseth that we the said
Shadrach Cobb Benjamin Beale & Elizabeth Beale for & in consideration of the sum of fifty
pounds current money to us in hand paid the receipt whereof we doth hereby acknow-
ledge have bargain'd sold aliened & confirmed & by the w^{ch} presents do grant bargain-
sell & alien & confirm unto the said William Harcom his heirs & assigns forever a certain tract
or parcel of Land lying within the county of Southampton bounded as follows Viz - Beginning at the
Black oak branch at a Willow oak thence down the center of the said branch to the mouth of the
Guar Swamp to a Black Gum Tree thence down the center of said Gum Swamp to the center
of the lower swamp thence along the center of the lower swamp to a small Willow on a straight
line to the Willow oak at the Beginning containing Twenty two Acres or there some more or
less Together with all the Accurions Remainders Rents Profits Services & Emoluments of the said
whatsoever of the said Shadrach Cobb Benjamin Beale & Elizabeth Beale for them selves & their
Premises and every part or parcel thereof & all the right Title Interest Claim & Demand
with all the appurtenances thereto belonging unto the said William Harcom his heirs & assigns
forever & the said Shadrach Cobb Benjⁿ Beale & Elizabeth Beale for them selves & their
heirs the said Land premises & every part or parcel thereof & against all and every other
