He the s^d Rogers hath granted bargain'd sold alien'd enfeofe'd confirm'd & delivered & by these presents doth grant bargain sell alien enfeofe confirm & deliver unto the s^d Tho Turner & John Reese their heirs & assigns forever the following (Parcels to wit) Part of the Old Peter, Lewis, Lewis, Anthony, Russell, Steven, Tom, Dill, Lucy, Frank, James, Mary & her four children, Call & her four, Violet & her four children also all my flock of Horses cattle Hogs & Sheep and all the estate right title Interest property claim & demand whatsoever of him the s^d John Rogers either in Law or equity for & to the s^d slaves & stock above mention'd every part & parcel thereof To have and to hold the s^d slaves & stock unto the s^d Tho Turner & John Reese their heirs & assigns forever To trust upon his special confidence & to the uses Intents & Purposes following that is to say that the s^d Tho Turner & John Reese at all times hereafter whenever they may be thereto requested by the said John Rogers or whenever the s^d Turner & Reese shall join them selves likely to suffer by means of the Securityship afores^d from any suit Judgment or Execution
