Between Jonas Bryant & Elizabeth his wife of the county of Sten in the state of Virg^a of the one part & Burrell Bryant of the county & state afores^d of the other part Witnesseth that the said Jonas Bryant & Elizabeth his wife hath for some consideration of the sum of five Shillings they do hereby acknowledge and own themselves fully satisfied & content. & therewith & hereupon have given granted bargain'd sold a land enff^d & confirmed & by these presents do give grant bargain sell confirm enff^d and confirm unto the said Burrell Bryant his heirs & assigns forever one certain Tract or parcel of land lying and being in the county of Sten afores^d containing by estimation one hundred & fifty Acre or there same more or less bounded as followeth to wit Beginning at a maple in the more branch thence along the said Barrows line to a white oak a corner of Bury^r Faircloth & John Barrows land thence along the said Barrows line to a gum standing in the little swamp thence down the Swamp to a pine a corner of James Wilkenson land thence to two black fumps thence down the branch to the Spring branch thence up the Spring branch to the Beginning of land W parcel thence to have and to hold all & singular the aforesaid Land & every part thereof with the appurtenances unto the said Burrell Bryant his heirs & assigns forever shall well warrant & forever defend by these presents In witness whereof the said Jonas Bryant & his wife have hereunto set their hands & affixed their seals the day & Year above written
