This Indenture made this 10 day of October in the year of our Lord Christ 1793 Between William Whitehead widow & Relict and Executrix of Jⁿ Whitehead decd (late of Ston) of the County & State of Virginia of the one part & Jacob Barrett of the same county & State afores^d of the other part Witnesseth that the s^d William Whitehead widow & Relict & Executrix of the s^d John Whitehead decd for her consideration of the sum of £90 Current money of Virg^a to her in hand paid by the said Jacob Barrett at or before the signing sealing & delivery of these presents the receipt whereof the s^d William Whitehead widow and Relict & Executrix of the s^d John Whitehead decd doth hereby acknowledge & her self thereunto fully satisfied contented & p^thatt bargain & sold alien & conveyed & confirm & by these presents doth hereby under the power & authority given in & by the last Will & Testament of the s^d John Whitehead decd bearing date the day of in the year 1791 bargain & sell alien & convey & confirm unto the s^d Jacob Barrett his heirs & assigns a certain Tract or parcel of land lying & being situate in the parish of St Lukes & County of Ston on the south side of Nottingham River & bounded as follows to wit Beginning at a Herry standing in Benj^a Whitfields line & corner to Jacob Barneiths running the courses of the Patent to the beginning being the same land granted by patent by his Excellency John Dimore Governor of the State of Virg^a unto Lewis Whitehead bearing date the 5 day of July 1771 Together with all houses orchards Gardens Orchard & woods in & wood mines & Minerals & other the Profits & Commodities thereto thereto belonging in or in any wise appertaining To have and to hold the s^d bargain & premises & every of the appurtenances unto the said Jacob Barrett his heirs & assigns forever to the only proper use & behoof of the said Jacob Barrett his heirs & assigns forever And the s^d William Whitehead widow & Relict & Executrix of the s^d John Whitehead decd doth hereby covenant & agree to and with the said Jacob Barrett his heirs & assigns in the following manner that is to say that she the said William Whitehead widow & Relict & Executrix of the said John Whitehead decd at the time of signing sealing & delivery of these presents stands lawfully seized & possessed of her the said bargain & premises in a good & pure estate & in fee simple that the same is fully paid & cleared of all debts and discharged of and from all manner of incumbrance whatsoever that she the said William Whitehead widow & Relict & Executrix of the s^d John Whitehead decd hath given
