This Indenture made this 10 day of Oct^r In the year of our Lord Christ 1793 Between John
 Taylor & Sarah his wife of the county of Southampton of the one part & John Blunt of the County of the
 other part Witnesseth that for and in consideration of the sum of £337 10^s Current money of
 Eng^d to the said J^r Taylor & Sarah his wife in hand paid by the said J^r Blunt at or before
 the sealing & delivery of these presents the receipt whereof the said J^r Taylor & Sarah his wife
 doth hereby acknowledge & thereof & of every part thereof do Egenerate & acquit the said
 J^r Blunt his heirs & assigns & every of them for & by these presents they the said
 J^r Taylor & Sarah his wife have granted bargain'd sold alien'd & confirm'd by these
 presents do grant bargain'd sell alien & confirm unto the said J^r Blunt his heirs & assigns
 forever all that tract or parcel of Land situate lying & being on the North side of the
 flat swamp in the county of Flou afores^d containing 450 Acres land & the same more
 or less & bounded as followeth (to wit) beginning on the Flat swamp a corner of the land
 belonging to the estate of Henry Thomas dec'd thence along the said line to David Blunt's line
 thence along the said Blunt's line
 line to Kitchen Turners line thence along the said Turners line to George Lays line thence
 along the said Lays line to the run of the Flat swamp thence down the various corner
 of the said Flat swamp to the Beginning To have & to hold the said land together with
 all the appurtenances thereunto belonging or in anywise appertaining and all its privi-
 ledges to the only proper use of him the said J^r Blunt his heirs & assigns forever
 free from the Lett Hindrances or incumbrances of the said J^r Taylor & Sarah his wife
 their heirs or assigns or any other person or persons claiming the same by force or
 under them the said John Taylor & Sarah his wife clear of all dues Will Right
 of power or any other incumbrances what so ever to the only proper use of him the said
 J^r Blunt his heirs & assigns forever & the said J^r Taylor & Sarah his wife
 for themselves & their heirs doth Promise to & with the said J^r Blunt his heirs
 & assigns that the right Title of the said 450 Acres of land & Premises & every part thereof
 against all Whom person or persons they will warrant & defend unto the said
 Blunt his heirs or assigns forever In Witness whereof the said John Taylor & Sarah his wife
 hath set their hands & affixed their seals the day & year first afores^d written
