This Indenture made this 16 day of Jan^y 1793 Between Jacob Barnes of the county of Stm & State of Vir^g of the one part & Tho^s Holladay of the same county & State a free^s of the other part Witness that the said Jacob Barnes for and in consideration of the sum of Ten Pounds current money of Vir^g taken in hand p^d by the said Thomas Holladay the receipt whereof the s^d Jacob Barnes doth hereby acknow- ledge they the said Jacob Barnes have granted bargain'd & sold a land & conveyance by their presents do grant bargain & sell a land & conveyance unto the s^d Tho^s Holladay his heirs & assigns forever one seat tract or parcel of land situate lying & being on the south side of Holloway River in the county of Southampton afores^d containing 175 acres it being the plantation whereon David Dalk formerly lived and by the s^d David Dalk by Indenture bearing date the 2^d day of Aug^r 1776 convey'd the said land & Plantation to Jacob Barnes party to these presents & bounded by the most known and antient bounds thereof & also the Reversion & Reversions Remainder and Remainders Rents Issues & services of the said premises every part & parcel thereof & all the estate Right Title Interest claim & demand whatsoever of them the s^d Jacob Barnes for & to the s^d part tract or parcel of Land & every part thereof To have & to hold the said part tract or parcel of Land & all & singular the premises above mention'd & every part & parcel thereof with the appurte- nances unto the said Tho^s Holladay his heirs & assigns forever to the only & proper use & behoof of the s^d Tho^s Holladay his heirs & assigns forever & the s^d Jacob Barnes for him self & his heirs the s^d part tract or parcel of Land & premises & every part thereof against him & his heirs to the said Tho^s Holladay his heirs & assigns shall and will warrant & forever defend & to this he is bound In Witness whereof the said Jacob Barnes have hereunto set my hand & seal the day & year first above written.
