sideration of annual rent of one penny hath bargain'd & leased & confirms by these
presents as Bargain Lease & conform unto the s^t & Samuel Calvert his heirs & assigns p^t
during the term of Ten years from the date these presents one certain piece of land
of Land containing by estimation one half acre be the same more or less situated by
being in the county afores^t & parish of Notley Beginning on the N side of the
main road at the corner line of Thos Clements running W 10 poles along & Clements
line thence N 10 poles thence E 10 poles to the main road thence S along Road 10
Poles to the beginning And all houses buildings Gardens Ways Waters water
courses profits commodities heredaments & appurtenances whatsoever to the premises
hereby leased & confirmed & every part thereof To have and to hold during the
term of Ten years afores^t to the only proper use & behoof of him the s^t & Sam Calvert his
heirs & assigns & the s^t & Sam Calvert do hereby oblige himself & heirs & assigns to pay
to the s^t & Joseph Holmes or his heirs & assigns ad mo the said sum of one penny
of Pennies for the term 10 years afores^t & then renounce all right or claim whatsoever to the premises
hereby granted as afores^t fully as if this bargain & lease had never been executed the parties
