This Indenture made this 12 day of Decr in the year of our Lord 1793 Between J^{es} Kitchen of Nash County & state of North Carolina & Sarah his wife of the one part & J^{es} Stephenson of Stm & state of Virg^a of the other part Witnesseth that the s^d J^{es} Kitchen & Sarah his wife for and in consideration of the sum of \$60 Good money of Virg^a to them in hand paid & for the sealing & delivery of these presents the receipt whereof they do hereby acknowledge & thereof & of every part & parcel thereof do fully acquit & discharge the s^d J^{es} Stephenson his heirs & assigns sole aliene release & confirm by these presents do grant bargain sell alien release & confirm unto the s^d J^{es} Stephenson his heirs & assigns forever one certain tract or parcel of land lying on the North side of the Lightwood swamp in the parish of Netoway & County of Stm aforesaid containing 105 acres more or less & bounded as followeth (to wit) Beginning at where Kitchen's mill head empties into the Lightwood thence down the main run of the Lightwood swamp to Little Bargrave line thence along the s^d Bargrave's line to a small pine thence along ^{lane} a corner tree between the s^d Kitchen & the s^d Bargrave thence along the s^d Bargrave's line to a pine in a pond a corner tree between the s^d Bargrave & J^{es} Lane thence along the s^d Lane's line to black Oak thence along the s^d Lane's line to a large pine a corner tree between s^d Lane & the s^d Hut area Burwell Barrett thence along Burwell Barrett's line to the Mill branch & then to the s^d Mill branch to the beginning Together with all & singular the houses out houses gardens gardens orchards woods underwoods waies waters water courses privileges profits commodities hereditaments & appurtenances to the s^d Land belonging or in anywise appertaining & the several and various Remainder & Remainders rents issues & services thereof of every part & parcel thereof also all deeds Evidences & writings touching or in anywise concerning the same To have & to hold the s^d tract or parcel of land & Premises with the appurtenances unto him the said J^{es} Stephenson his heirs & assigns to the only proper use & behoof of him the said J^{es} Stephenson his heirs & assigns forever the said J^{es} Kitchen & Sarah his wife for themselves their heirs & assigns & as account grant bargain to & with the s^d James Stephenson his heirs & assigns that they the s^d J^{es} Kitchen & Sarah his wife the said tract or parcel of land & Premises with the appurtenances unto the s^d J^{es} Stephenson his heirs & assigns from against the claims of themselves & their heirs & assigns against claim or claims of all Whome Person or Persons whatsoever shall & lawfully warrant & have defend by these presents In Witness whereof the s^d J^{es} Kitchen & Sarah
