This Indenture made this 9th day of Nov^r in the year of our Lord Christ 1793 between
Edwin Simmons & Rebecca his wife of the county of Stm^r & parish of Wittingway of the one part &
Abridgton Harvey of the State of North Carolina of the other part Witnesseth that the
said Edwin Simmons & Rebecca for the consideration of the just & full sum of \$20 cur^t
money of Vir^a by the said Abridgton Harvey to them in hand paid at or before then sealing
& delivery of these presents the receipt whereof the said Edwin Simmons & Rebecca his wife doth
hereby acknowledge & whereof acquit & discharge the s^d Abridgton Harvey his heirs & assigns
forever & doth hereby acknowledge themselves therewith to be fully & entirely satisfied contented
& paid they the said Edwin Simmons & Rebecca his wife have granted bargained & sold unto
the said Abridgton Harvey his heirs & assigns forever all that tract tenements plantations &
parcels of land situate lying & being in the afores^d county of Stm^r & parish of Wittingway containing
by estimation 400 acres or less it being the same land that Wm^o Jones son of
Abridgton Jones dead & his wife & his heirs & assigns by his last will & Testament duly recorded
in the county court of Stm^r gave unto the afores^d Edwin Simmons & his wife 100 acres purchased of
John Hall & Ann his wife & since purchased of John Boll called Bryants Quarter 200 acres pur-
chased of Rich^d Williams adjoining thereto & 80 acres lying between the upper end of the State
& Johnsons land was given to the afores^d Wm^o Jones dead by his father Abridgton Jones dead as
