This Indenture made this 11 day of April in the year of our Lord 1793 between
 Meriam Scott of the county of Sten & parish of Northway of the one part & Caum Drake of
 the county & parish aforesaid of the other part Witnesseth that the s^d Meriam Scott for in
 consideration of the just & full sum of £45 current money of Eng^l by the s^d Caum Drake then
 in hand paid before the sealing & delivery of these presents the receipt whereof the s^d Meriam
 Scott doth hereby acknowledge and thereof acquit & discharge the s^d Caum Drake his heirs &
 assigns forever & herself fully & entirely satisfied & contented & paid hath granted bargained
 sold alien'd enfeoff release set over deliver'd & confirm'd by these presents doth grant
 bargain sell alien enfeoff release set over deliver & confirm unto him the said Caum Drake
 his heirs & assigns forever all that plantation meadow tract & parcel of land whereon the said
 Caum Drake now lives situate lying & being in the county of Sten & parish of Northway aforesaid & along
 all the lands which the s^d Meriam Scott bought of J^r Beaton saving to my son J^r Scott his heirs
 & assigns forever so much thereof as is or shall be at any time hereafter deemed by the adjoining
 Mill Pond containing by estimation 57 acres be the same more or less & bounded as by the great
 J^r Beaton's deed to the said Meriam Scott is expressed & all the houses out houses & outhouses
 woods ways waters & water courses low grounds pastures profits commodities & advantages & appurtenances
 whatsoever to the farms belonging or in anywise appertaining & the reversion & reversions remain
 & remainders unto J^r Scott & his heirs & assigns forever To have and to hold the said plantation meadow tract
 & parcel of fifty seven acres of land & premises with all & every the appurtenances aforesaid unto him the
 Caum Drake & his heirs & assigns forever to the only proper use & behoof of him the s^d Caum Drake & his
 heirs & assigns forever And the said Meriam Scott for her self her heirs & assigns forever
 assigns the said plantation meadow tract & parcel of 57 acres & premises with the appurtenances
 aforesaid unto him the s^d Caum Drake & his heirs & assigns forever against her the said
 Meriam Scott her heirs & assigns forever & assigns & against all persons whatsoever claiming or
 demanding the same or any part or parcel thereof from for by or under her shall & will
 warrant & forever defend by these presents In Witness whereof the said Meriam Scott
 hath hereunto set her hand & affix'd her seal the day & year first above written
