 let & by these presents doth demise grant & give unto the said Wmth brichlow his heirs & assigns a signifi-
 cant tract or parcel of Land containing 200 acres more or less lying being the parish of Nettoway & the said
 county of Stan & bounded as follows viz (Beginning at the Church landing running along & bound to the
 black hole then following the church running along the old field next to the low ground to the post line
 then running along Low line to the river then running up the River to the Church landing at the
 Beginning) Together with all the profits Privileges & appurtenances whatsoever to the said Demises belonging
 in anywise appertaining To have and to hold the said 200 acres Land & other premises with the appur-
 tenances unto the said Wmth brichlow his heirs & assigns & for the full term of 99 years to commence
 from & after the 1st day of Jan^y which shall be in the year of our Lord 1794 & the said Wmth brichlow for himself
 his heirs & assigns doth covenant & agree with the said Samuel Moody that he will not cut
 down or destroy any timber trees belong to said Land other than what shall be required for fences
 & other necessary purposes in cultivating the said Land & also that the said Wmth brichlow his heirs & assigns
 shall not cultivate above 10 acres of the said Land that has not been cultivated already & that the said
 brichlow for himself his heirs & assigns doth further agree with the said Moody that he the said
 brichlow will well and truly pay all the taxes which may become due for the said Land & the
 remainder of the said tract of Land that belong to the said Sam^l Moody for & during the term
 of years & the said brichlow doth grant & permit the said Moody the free privilege & authority
 into & upon the said Land at any time during & term hereby granted for the purpose of cutting
 & carrying away whatever timber the said Moody may want from the said Land for all & any
 purpose or purposes whatever and the said parties Indenture do for themselves covenant
 agree mutually with each other that if either of the parties shall fail in his compliance with
 all or any one or more of the above covenant & agreements that the party so failing shall pay
 & pay to other party the just & full sum of £100 current money of Eng^l In testimony whereof
 we the parties to these presents have returned to our hands & seal this 10 day of August 1793
 The said brichlow doth further agree that the said Moody shall have a free privilege of
 raising stock of any kind on the said Land during the term mentioned
