This Indenture made this 21<sup>st</sup> day of October in the year of our Lord Christ 1793 Between Rids  
Scarthough of the county of Bladen State of N Carolina of the one part & Rids Ricks of the county of Stan-  
& State of N C of the other part witnesseth that the sd Rids Scarborough & in consideration of  
sum of £30 current money of Eng<sup>t</sup> to him in hand paid by the sd Rids Ricks the receipt whereof doth the s  
Rids Scarborough with hereby acknowledging they the sd Rids Scarborough have granted bargained &  
sold alien & confirmed by these presents with grant bargain & sale alien & confirmed unto the sd Rids  
Ricks his heirs & assigns upon one seat tract or parcel land situate lying & being on the north side  
of Nottoeay River in the county of Stanly a tract containing 100 acres to the pine immediately  
bounded as follows to wit Beginning at the burying ground at a white oak a live tree between  
Asd Ricks & Rids Scarborough thence along the said line to pine a corner tree between Asd
