 of the sum of £40 current money of Virg^a to them in hand paid at or before the making & giving
 of the receipt whereof we do hereby acknowledge the said James Maget then & now El^d
 Maget Nich^l Maget Jr. El^d & his wife Sam^l Maget Jeremiah Daughtry &
 Susanna his wife & El^d Maget do hereby acknowledge & discharge hath granted bargain'd
 Release & confirm & by these presents doth fully & absolutely grant bargain'd
 confirm unto him the said J^l Maget all his right title interest or claim for the said
 tract or parcel of Land being in the s^d county of Sten & on the north side of the Bay
