This Indenture made this 7 day of Sept. in the year of our Lord Christ 1793 Between
 Henry Porter & Martha Porter his wife of the county of Stm & Parish of St Lukes of the one
 part & John Powell of the county and parish afores^d of the other part Witnesseth that
 Henry Porter & Martha his wife for and in consideration of the sum of £20. 8. 3 in m^t
 Lawfull money of Virg^a to them in hand paid on before the sealing & delivery of these
 presents the receipt whereof we the said Henry Porter & Martha his wife with hearty
 acknowledge hath bargain'd sold alien'd & compris'd unto the said John Powell his
 heirs & assigns forever one certain tract or parcel of land situate lying & being in the
 county lying on the south side of the three creeks & bounded as followeth To wit beginning
 at a Large Pine thence North 10 degrees East 39 pole to a red oak bush thence North 15
 degrees West 153 Poles to a pine Thence south 14 degrees west 12 pole to a Hickory &
 from thence to the beginning containing 24 1/2 Acres To have and to hold the said 24 1/2
 Acres of land with all & singular the appurtenances thereto belonging to the said
 John Powell his heirs and assigns forever to the only proper use behoof & of the
 said John Powell his heirs and assigns forever & the said Henry Porter & Martha his wife
 doth for themselves & their heirs further covenant & agree with the said John Powell his
 heirs & assigns that the said Henry Porter & Martha his wife their heirs & assigns shall
 and will warrant & forever defend the above mentioned land & premises unto the said
 John Powell his heirs & assigns forever against the claim or title of all Vnlawfull persons
 whatsoever In Witnes^s whereof the said Henry Porter & Martha his wife hath hereunto
 set their hands & seals the day & year above written
