Witnesseth that the said Benj^m Whitfield Sen^r and Mary his wife for and in consideration
of the sum of £100 current money of Benj^m to them in hand paid by the s^d Benj^m Whitfield Jun^r at
and before the enrolling and delivery of these presents take receipt whereof they the s^d Benj^m
Whitfield Sen^r & Mary his wife doth hereby acknowledge themselves therewith fully satisfied
contented and paid have bargain sold alien & conveyed by their free will
doth hereby bargain & sell alien & convey and forever confirm unto the said Benj^m Whitfield
Jun^r his heirs and assigns a certain messuage Plantation Tract or parcel of land situate
lying and being in the Parish & County afores^d containing by Estimation 335 acres to the
same more or less bounded as follows (to wit) Beginning at a white oak on the side of Shaws
branch a corner Rich^d Dewols line thence the s^d Dewols line to a pine another corner
in the s^d Dewols line thence the said Dewols line to a red oak in Abraham Whiteheads
line thence the s^d Whiteheads line to a pine a corner Tree thence the said Whiteheads
line to the corner of the May branch thence down the river to a pine a corner between Edward
Connel and Sarah Ferguson thence by the said Ferguson line to a bay in Edwards
line thence the said Edwards line to a small Hickory thence the said Edwards line to
a light wood stake a corner thence the s^d Edwards line to the beginning together with all
houses out houses Gardens Orchard ways waters water courses wood & underwood mines
minerals & all other the Profits & Common & duties thereto belonging or in anywise appe-
taining To have and to hold the said bargain & promise with the appurtenances to the
said Benj^m Whitfield Jun^r his heirs and assigns forever with their heirs in & to their heirs
remainder & remainders unto Jones & Proffitt thereof and every part & parcel thereof
and the said Benjamin Whitfield Sen^r & Mary his wife for themselves their heirs and
