This Indenture made this 11th day of May in the year of our Lord 1794 Between Mary Norfleet of Southampton county Widow of the one part & John Wilkinson of the same County of the other part Witnesseth that the said Mary Norfleet for and in consideration of the sum of Two pounds Virginia money in hand paid her before the Execution of these presents by the said John Wilkinson the receipt whereof she hereby acknowledge & for divers other good causes & considerations hereunto moving hath given granted bargained sold assigned & let over by these presents doth give grant ~~grant~~ bargain sell assign & let over unto him the said John Wilkinson all the estate right title & Interest within Law except which the said Mary Norfleet hath or is entitled to in the estate both real & Personal of said Norfleet dec'd with unity the last will & testament of the said David Norfleet dec'd or in right of Dower by law together with all Privileges Emoluments Hereditaments & Appurtenances to the said Estate both real & Personal belonging or in any wise appertaining To have & hold the said bargained premises & every part & parcel thereof with Appurtenances to him the said John Wilkinson his heirs & assigns to the only proper use & behoof of the said John Wilkinson his heirs & assigns forever & the said Mary Norfleet for her self & her heirs Executors & Adorsors doth hereby covenant Warrant & Warrant to the said John Wilkinson that he the said John Wilkinson his heirs & assigns shall & lawfully hold & enjoy the said bargained premises & every part & parcel thereof forever unincumbered & discharged against the claim right or title of her the said Mary Norfleet shall & will at any time hereafter upon request by the said John Wilkinson do make & execute all such other just due Act or Acts things or things which may be reasonably necessary & proper the more certainly & Effectually to secure & confirm the said Will of the said Mary Norfleet in the said John Wilkinson as aforesaid according to the true intent & meaning of the said Will of the said Mary Norfleet hath hereunto set her hand & seal this day & year above written
