This Indenture made this 13th day of March in the year of our Lord Christ 1795 Between John
of the county of Southampton and State of Virginia of the one part and Sarah Wile of the same county and State of
the other part Witnesseth that the Joshua Test for and in consideration of the sum of Eight hundred
money of the State of Virginia to him in hand paid by the said Sarah Wile at and before the signing hereof
and delivery of these presents the receipt whereof the said Joshua Test doth hereby acknowledge himself to be
fully satisfied contented and paid here bargained & sold by these presents doth hereby bargain sell assign
and forever confirm unto the said Sarah Wile his heirs and assigns a certain lot or half acre of land lying &
being situate in the Town of Annsborough in the said county of Southampton and State of Virginia and distinguished
by the Surveyors plan of the said Town by the Number three three 3 Bounded as follows to wit
Beginning at the corner point of Number two thence running on the same to the back corner thence running
on the River to the back corner of Number four thence running on the same to the front corner thence
the beginning containing One half acre of land - Together with all houses & houses ways & streets
courses mines & minerals People and commodities thereto belonging or in anywise appertaining unto
the said right title Interest claim and advantage of the said Sarah Test To have and to hold the
said bargain & premises with warranty of the approbation unto the said Sarah Wile his heirs & assigns
forever with the reversion & reversioners remainder & assigns unto of good & lawful Right Power
