This Indenture made this 9th day of July in the year of our Lord 1795 between Silas Vick & Margaret his wife of Virginia County of Southampton of the one part & Arthur Whitehead of the county of State aforesaid of the other part Witnesseth that the said Silas Vick & Margaret his wife for and in consideration of the sum of Twenty three pounds five Shillings current money of Virginia to them in hand paid by the afores^d Arthur Whitehead the receipt whereof we do hereby acknowledge have granted bargain'd sold Alienated & confirm'd by these presents do grant bargain sell alienate & confirm unto the said ^{before} Arthur Whitehead his heirs & assigns four forty six acres & half of land more or less lying & being in the county of Southampton & on the south side of Mattoway River & bounded as followeth Beginning at a pine a corner between John Jackson & the afores^d Silas Vick then a North west corner along a line of mark'd trees between the afores^d Arthur Whitehead & Silas Vick to a pine a corner then East along a line of mark'd trees to a Sassafras a corner then a fourth East corner along a line of mark'd trees to a pine a corner between the afores^d Whitehead & Vick then East along a line of mark'd trees to a pine a corner then South East along a line of mark'd trees to a pine a corner then west along a line of mark'd trees to the beginning & also the reversion or reversions Remainder & Remainders with all & singulars of the said land & premises Every part & parcel thereof & Water all the right title claim & demand of whatsoever of the said parties of or to the said land & premises Every part & parcel thereof & Lease Hold & all & singular the said land above mentioned & Every part & parcel thereof with the Appurtenances unto the afores^d Arthur Whitehead his heirs & assigns forever & we the s^d Silas Vick & Margaret for ourselves our heirs & assigns the said land & premises Every part & parcel thereof & against ^{all} Every other person or persons whatsoever shall & will warrant & defend free & clear from all incumbrances whatsoever In witness whereof we have hereunto set our hands & seals the day & Year above written.
