This Indenture made this 8th day of October in the year of our Lord 1795 Between Hardy Lawrence, Samuel Roe, & his wife Mary Roe of Southampton County Mills Darden & his wife Pamela & Robert Lawrence of the county of Isle of Wight of the one part & Daniel Simmons of the county of Southampton of the other part Witnesseth that the said Hardy Lawrence Samuel Roe and his wife Mary Mills Darden & his wife Pamela & Robert Lawrence for and in consideration of the sum of fifty pounds to them in hand paid at or before the sealing and delivery of these presents they receipt whereof the said Hardy Lawrence Samuel Roe and his wife Mary Mills Darden & his wife Pamela & Robert Lawrence do hereby acknowledge hath granted bargained & sold aliened conveyed & by these presents doth fully grant bargain sell alien convey unto the said Daniel Simmons one half of black creek mile containing six acres of land on the south side joining to the said Samuel Roe & his wife Mary Mills Darden & his wife Pamela & Robert Lawrence one acre of land on the north side joining William Milnes land to the said Daniel Simmons or his heirs & assigns forever to have and to hold the said land & premises unto the said Daniel Simmons his heirs & assigns forever to the only purpose & behoof of him the said Daniel Simmons and his heirs and assigns forever In Testimony whereof we have hereunto set our hands & seals the day & year above written
