This Indenture made this 8th day of October in the year of our Lord 1795 in the 17th year of American Independance between Robert Lawrence Mills Darden & wife Pamela of the others to Isle of Wight county & Samuel Roe & wife Mary of Southampton county & parish of Nottway of the Lawrence one part & Hardy Lawrence of the said county & parish of the other part Witne full that the said Robert Lawrence Mills Darden & wife Pamela & Samuel Roe & wife Mary of the said Hardy Lawrence for and in consideration of the sum of thirty pounds Virginia currency to them in hand paid by the said Hardy Lawrence the receipt whereof they doth hereby acknowledge hath granted bargain'd sold alien'd released & confirm'd by these presents doth grant bargain sell alien release & confirm unto the said Hardy Lawrence to him his heirs & assigns forever all that plantation tract or parcel of land & premises with the appurtenances formerly belonging to a deceased Thomas Lawrence now in tenure & occupation of the said Hardy Lawrence to him his heirs & assigns situate lying & being in the parish & county aforesaid on the south of black water river containing by estimation & more or less bounded as followeth Viz beginning at the mouth of Nohead Gut then up the said Gut to an Oak a corner tree of Cape Turners land thence a long line of mark'd trees to a pine a corner tree of William Milners land thence a long line of mark'd trees to a red oak a corner tree of Hardy Lawrences land thence a long line to the said black water thence up the s^d river to the first station and all houses on the said & adjacent building yards gardens orchards trees ways waters watercourses priviledges profits & common rights & appurtenances to the said tract or parcel of land belonging or in anywise appertaining and the reversion & reversions & remainders & remainderments & rents & profits thereof and all the estate right title & law full possession property claim & demand whosoever they the said Robert Lawrence Mills Darden Samuel Roe & wife the the same being thereof and all deeds evidences & writings touching or in any way concerning the same To have and to hold the said plantation tract or parcel of land & premises with the appurtenances unto the said Hardy Lawrence his heirs & assigns forever & the s^d Robert Lawrence Mills Darden & Samuel Roe for themselves their heirs & assigns
