This Indenture made this day of in the year of Christ on the
seventy nine and ninety six between Samuel Kelloe of the County of Southampt
ton of the one part and Robert Sheld of the county after aid of the other part
witnesseth that the said Samuel Kelloe for and in consideration of the sum of five
dollars to him in hand paid by the said Robert Sheld the receipt whereof he the said
Samuel Kelloe doth hereby acknowledge and thereof acquit and discharge the said Robert Sheld
his heirs executors and administrators forever hath granted bargained sold and
confirmed and by these presents doth grant bargain sell alien and confirm unto the said
Robert Sheld his heirs and assigns one certain tract or parcel of land lying and being
in the county of Southampton and parish of Notley containing by estimation one
acre to the same more or less and bounded as follows To wit Beginning at the main road on
William Washingtons line at the corner of his fence Thence up the road S.W to a small pine
35 yds from thence near S.E. to a small thence to a red oak thence to another red oak
thence to a pine tree from thence to a post oak a live tree in the said Robert Shelds
land in a small dry branch 140 yds thence nearly N.E. to a corner tree near William
Washingtons fence a corner tree between the said William Washington and Robert
Sheld hence N.W. along Washingtons line to the main road or first station and
also all houses out houses ways waters & diversances profits & conveniences hereditamentum
appertaining to the same belonging or in any wise appertaining and the reverend and
revisions remainder and remuneration unto others and profits thereof and of every part thereof
and all the estate right title interest claim and demand whatsoever of him the said Samuel
Kelloe of in and to the same or any part thereof to have and to hold the said tract or parcel
of land and premises hereby granted bargained and sold unto the said Robert Sheld
his heirs and assigns forever to only propuse and take of him the said Robert Sheld
his heirs and assigns and the said Samuel Kelloe for himself his heirs executors and
administrators with hereby covenant promise and agree to and with the said
