This INDENTURE made this twelfth day of January in the year of our Lord Christ one thousand seven hundred and ninety six between Simon Everett of the county of Southampton of the one part and Jefse Holt of the country aforesaid of the other part witnesseth that as well for the purpose of securing the said Jefse Holt in the sum of one hundred and eighty pounds Virginia currency which sum is fully expressed in a bond from the said Simon Everett unto the aforesaid Jefse Holt bearing date the twentieth day of January in the year one thousand seven hundred and ninety six also for the sum of dollars to him in hand paid by the said Jefse Holt the receipt whereof the said Simon Everett acknowledge grant bargain and sell unto the said Jefse Holt and to his heirs executors administrators and assigns all that his aforesaid land wherein the said Everett now lives containing by estimation two hundred and fifty acres and bounded according to the known ancient and reputed bounds of the said tract aforesaid of land to have and to hold the plantation or parcel of tract of land and premises with the appurtenances unto the said Jefse Holt and to his heirs executors administrators and assigns and the said Simon Everett for himself his heirs executors administrators and assigns shall hereby covenant and grant to and with the said Jefse Holt his heirs executors and assigns to warrant and defend the title of the said hereby granted land and premises to the only proper use and behoof of him the said Jefse Holt his heirs executors administrators and assigns against the title claim or demands of him the said Simon Everett his heirs executors administrators and all and every other person whatsoever interest aforesaid and upon the special condition and confidence that the said Jefse Holt his heirs executors administrators and assigns shall after the twenty fifth day of December next ensuing the date hereof at such time as he or they may think proper or soon if the said Everett shall request the same sell at publick auction (for the best that can be got) the hereby granted land and premises after giving due and proper notice of such intended sale at least thirty days before the sale thereof and out of the money arising from such sale and charge pay and satisfy the aforesaid amounting as before agreed to the sum of one hundred and eighty pounds Virginia currency to gether with the interest arising thereon and the costs of removing this indenture and the contingent charges on the sales of said land and premises And the said Jefse Holt doth hereby for himself his heirs executors administrators and assigns covenant promise
