This Indenture made the thirteenth day of October anno Domini one thousand seven hundred and ninety six Between Edwin Gray James Wilkinson Samuel Kello Benjamin Blunt Thomas Ridley Benj<sup>a</sup> Ruffin Robert Goodwyn and John Faylor Gentlemen trustees or a majority of them as appointed by act of <sup>the General</sup> Assembly of Virginia; bearing date Dec<sup>r</sup> the seventh Anno Dom 1791 for the purpose of laying off a town by the name of Jerusalem on the land of Joseph & William Scott adjoining the court house of Southampton of the one part and Joshua Fort of the other part. Witnesseth that the said trustees as aforesaid, for & in consideration of the sum of <sup>current</sup> money of Virginia to be paid by the said Joshua Fort pursuant to the <sup>said</sup> act to the said <sup>Joshua Fort</sup> Scott is bargained sell alie & confirm unto the said Joshua Fort & his heirs forever one lot or parcel of Land lying and being in the said town of Jerusalem numberd fourteen, and bounded as follows Viz<sup>t</sup> beginning at the north west corner of H<sup>o</sup> thirteen, on the east side of the main street, thence along the main street 90 feet 4 Inches to the south west corner of H<sup>o</sup> fifteen, thence along the line H<sup>o</sup> 15, 237 feet 9 Inches to Scotts land, thence along Scotts line 90 feet 4 Inches to the north east corner of H<sup>o</sup> 13, thence along the line of H<sup>o</sup> 13, 237 feet 9 Inches to the
