This Indenture, made this tenth day of July, in the year of our
 Lord, one thousand seven hundred, and ninety seven, between
 William, of the County of Southampton of the one part, and Josiah
 Joiner, & Ethio Joiner, of the same County of the other part,
 10th, 1805, thenceforth, and in consideration, of the good will, love, and
 affection, the said Joshua Ellinian and both for, and bearetof his
 his nephews, the aforesaid Josiah & Ethio Joiner, but more espe-
 cially, for and in consideration of the said Josiah Joiner & Ethio
 Joiner, their heirs or assigns, providing for, and furnishing the said
 Joshua Ellinian, and Catherine his wife with necessaries suitable
 for their comfortable support, & maintenance for, and during
 their natural lives, to the amount or full value of sixteen
 2^d July 1805 of Indian money for each of them, if so much should be
 required, and also for and in consideration of the just and full
 sum of five shillings Current money of Virginia, by the said
 Josiah Joiner & Ethio Joiner, to the said Joshua Ellinian in full
 paid, before the ensailing, and delivery of these presents, there-
 ceipt whereof the said Joshua Ellinian doth hereby acknowledge
 and thereof receipt and discharge, the said Josiah Joiner, and
 Ethio Joiner, their heirs, and assigns, and himself therewith
 fully and entirely, satisfied, and contented, The said Joshua
 Ellinian, hath given, granted, bargained, sold, alienated
 unfeoffed, set over, delivered, and confirmed, and by these presents
 doth give, grant, bargain, sell, alien, enfeoff, release, set over, deliver
 and confirm, unto the said Josiah Joiner & Ethio Joiner, and to his
 heirs, and assigns forever, All that plantation, all usage, and
 & service of land, wherein the said Joshua Ellinian now liveth
 situated, lying, and being in the County of Southampton, a tract
 adjoining Black Creek several, containing by estimation, one hun-
 dred and sixty five acres, be the same more or less, bounded
 described as by the dees for the same is expressed, and being all
 the lands in the possession or seized of the said Joshua Ellinian
 and all the houses, out houses, Cottages, buildings, Woods, water,
 waters, and water courses, pasture, commodities, hereditaments,
 appurtenances, whatsoever to the same belonging, or in any wise
 pertaining, and the reversion & reversions, remainders, &
 Rents, Issues & profits thereof, and all the estate, right title
 claim or demand of him the said Joshua Ellinian of himself
 same, and every part, and parcel thereof, also my right, &
 Wth strings, & pieces, & fields, & lands, & annuities, & other effects
