This indenture made this 14th day of January, in the year
of Christ, one thousand seven hundred and seventy seven, between
Ezra Scott, and Anne his wife of the County of Isle of Wight, the one
part, and William Hart of the County of Southampton of the other part
witness, that for and in consideration of the sum of
current money of Virginia by the said William Hart, to the said Ezra in
hand paid, at or before the sealing & delivery of these presents, the receipt whereof
he the said Ezra Scott, doth hereby acknowledge, and thereof acquit, and dis-
charge the said William Hart, his executors, and administrators, they the
said Ezra Scott, and Anne his wife, have granted, bargained, sold, aliened,
enjoyed and confirmed, and by these presents, do give, bargain, sell,
alien, enjoy, and confirm, unto the said William Hart, his heirs, and as-
signs, one certain tract or parcel of Land lying in the County of Southampton
and adjoining the town of Jerusalem, in the said county, and contain by
estimation one Acre, and bounded as follows to wits, Beginning at the North
west corner of Doct. James Swinns Land, thence along the said North side
degrees west seventeen poles, thence North by the said degrees east, seven
Poles, thence along the town line South by the said nine degrees East to the South
east Corner of the Doct. James Swinns Land, and all houses, buildings, per-
taining, ways, waters, watercourses, profits, commodities, hereditaments and
appurtenances, so the same belonging, or in any wise appertaining, and the
reversion, and reversions remaines and remainders, rents, issues and profits there-
of, and all the estate, right, title, interest, property claim, and demand of them
the said Ezra Scott, and Anne his wife, of in and to the same, and every part
and premises, with their, and every of their appurtenances, unto the said
William Hart, his heirs & assigns forever. And the said Ezra Scott & Anne
his wife, for themselves, their heirs & executors, & Administrators do covenant
promise and grant to and unto the William Hart, his heirs and assigns
that he the said William Hart, his heirs and assigns, shall and may
from time to time, and at all times hereafter, peaceably and quietly use
hold, use, occupy, possess and enjoy, the said tract of Land & premises with
all the said premises, and receive the profits thereof without the let, a molestation
of them the said Ezra Scott & Anne his wife their heirs, and all and
every person, claiming by from or under them, any right title or interest
in the premises before mentioned with their appurtenances, shall & will
from time to time, and at all times hereafter, at the reasonable request
at the Cost and Charges in the law of the said Ezra Scott and Anne his wife
their heirs and assigns, make do and execute, or cause to be made and done
in the law, whatsoever, for the further and more perfectly enjoying the said
Land & premises, with all their appurtenances unto the said William Hart
his heirs and assigns, as he the said William Hart his heirs & assigns
or his, or their counsel learned in the Law shall be devised, advised or
required. And lastly that they the said Ezra Scott & Anne his wife
and their heirs, all and singular the before mentioned premises of
every part and parcel thereof, with their appurtenances unto the
