This Indenture made this twenty first day of March
in the year of our Lord Christ, one thousand seven hundred and
ninety seven, Between Samuel Worran Jr. of the County of
Southampton and state of Virginia of the one part, and Josiah
Vick of the same County and state of Virginia of the other part
Witnesseth, that the said Samuel Worran Jr. being indebted
unto the said Josiah Vick, the sum of one hundred and
forty five pounds current money of Virginia to be paid unto
the said Josiah Vick his certain attorney his heirs or executors
administrators or assigns on or before the twenty first day of
September next ensuing next ensuing the date hereof -
and whereas the said Samuel Worran Jr. is willing and desirous of secur-
ing the payment of the said one hundred and forty five pounds unto the
said Josiah Vick his heirs, executors, administrators or assigns by con-
veying unto him an absolute right and title, to two Negroes (to wit)
Negro man Bob & Cooney, vesting in him the said Josiah Vick
his heirs (and) all interest right, title claim &c. and of in and
to the said Negroes Bob & Cooney - Now this Indenture wit-
nesseth that in pursuance of the premises aforesaid, and for divers good
causes, him thereunto moving, but more especially for and in consid-
eration of the sum of six shillings current money of Virginia to him in
hand paid by the said Josiah Vick, at and before the signing, sealing &
delivery of these presents, the receipt whereof the said Samuel Worran Jr.
doth hereby acknowledge, and himself therewith satisfied & contented, he
paire, have bargained & sold, & delivered & by these presents doth hereby
bargain & sell & deliver, unto the said Josiah Vick his heirs and assigns for
ever, the aforesaid Negroes Bob & Cooney, at the time of signing & delivery
of these presents, the proper right and title of the said Samuel Worran
Jr. to have and to hold the said Negroes Bob & Cooney unto the said
Josiah Vick his heirs and assigns, to the only proper use and behoof
of the said Josiah Vick his heirs and assigns forever, as aforesaid
