This Indenture

made this sixteenth day of December in the
 year of our Lord Christ, one thousand seven hundred and ninety seven, between
 Jordan Willaford and Cherry his wife of the County of Southhampton of the
 one part, and Moreland Delle of the County of West of the other
 part, Witnesseth that they the s^d. Jordan Willaford and Cherry his wife for
 in consideration of the sum of one hundred and fifty four pounds current
 money of Virginia to them in hand paid by the said Moreland Delle, the
 receipt whereof they do hereby acknowledge, have granted, bargained, sold,
 aliened & confirmed & by these presents do grant, bargain sell, alien & confirm
 unto the said Moreland Delle, his heirs and assigns forever, one certain
 tract or parcel of land devised to me the s^d. Jordan Willaford by my
 Father William Willaford dec^d. lying and being on the south side of
 Black water swamp, and bounded as followeth *viz* beginning at a
 white oak below Proctors bridge on the main run of Black water,
 thence up the main water course to a sassafras Gum, thence along
 a line of marked trees, a westwardly course to a beach adjoining
 the lands of Thomas Pictors, thence down the Pearson branch a
 southwardly course to a sassafras Gum, on Pictors road, thence down the
 said Pictors road to the first station. containing by estimation one
 hundred and twenty five acres, be the same more or less, together with
 all Woods, underwoods, Ways, Waters, Water Courses, perfects commodities
 Advantages, Hereditaments & appurtenances whatsoever to the said lands
 in any wise appertaining, the reversion and reversions, remainers & remainders
 rents and profits of the same and every part thereof, & all the estate rights
 Title, Interest, property claim & demand, whatsoever of them the said
 Jordan Willaford & Cherry his wife or their heirs, of us and to the same
 and every part thereof, to have and to hold the said land (appertaining
 to the true intent of these presents,) unto the said Moreland Delle his
 heirs and assigns, to the only proper use and behoof of him the said
 Moreland Delle his heirs and assigns forever, and they the said Jordan
 Willaford and Cherry his wife, for themselves, their heirs, Executors & Admin^{rs}
 do covenant, promise, grant, & agree, to and with the said Moreland Delle
 his heirs and assigns, in manner and form following *viz* that they the
 said Jordan Willaford & Cherry his wife, their heirs & all and every other person
 or persons claiming any estate or Interest in the s^d. Land & premises in any
 sort thereof, by form, in order thereto or any of them, shall and will never
 come to be made void and evicted, any further or other conveyances or
 assurances in the law, for the better and more perfect conveying and
 assuring the said land & premises unto the said Moreland Delle his
 heirs forever, against the lawful claim, title & demand of all and every
 Person or persons whatsoever, shall and will warrant and save release
 by these presents In Witness whereof we have hereunto set
