This MDCCLVII made this sixteenth day of July in the year
of our Lord, one thousand seven hundred & ninety seven, between
Hairy Pope of the County of Southampton & parish of Mottey of the
one part, and Jordan Denson & Joseph Denson of the same County &
parish, witnesseth that the said Hairy Pope, for and in consideration
of the just and full sum of three hundred pounds, current money of
Virginia by the said Jordan Denson to him in hand paid before the
witnessing and delivery of these presents, and the further sum of
fifty seven pounds, thirteen shillings & 6d. current money of Virginia
to him in hand paid by the said Joseph Denson, before the witnessing &
delivery of these presents, the receipt whereof the said Hairy Pope doth
hereby acknowledge, and thereupon acquit and discharge the said Jordan
Denson & the said Joseph Denson, and each of them, and each and
every of their, or either of their heirs, executors, administrators, and
assigns, and himself therewith fully and entirely satisfied contented
space, the said Hairy Pope hath granted, bargained, sold, aliened
enfeoffed released, set over, delivered & confirmed, and by these present
doth grant, bargain, sell, alien, enfeoff, release, set over, deliver and
confirm, unto the said Jordan Denson, & Joseph Denson, and unto their
and each of their heirs and assigns forever, all that plantation messuage
tract, and parcel of land, situate, lying & being in the County of South-
ampton, aforesaid on aro adjoining Mottey River, near the town of
Jerusalem, and wherein William Rayford, was living, containing by a
late mensuration, about six hundred and twenty acres, and being all the
lands, which my Father the late Hairy Pope, purchaser of John
Johnson, and bounded according to the known proprietaries therupn, as is
repealed, and declared, by the deed or deeds, for the same, and all the
houses, out houses, Edifices, buildings woods, ways, waters, & water-
courses, gardens, orchards, low grounds, pastures, barns stables, heri-
taments & appurtenances whatsoever to the same belonging, in any
wise appertaining, and the reversion and reversions, remainders & annuities
and, & profits thereof, and all the estate right, title, interest claim
and demand of him the said Hairy Pope, of in, and to the same, and
every part and parcel thereof, also my two copper mill pells, Paps Grounds,
all the Crops I have now growing, the whole of the said Hairy Poles Stock of
Horses, cattle, hogs and sheep, House hold and Kitchen furniture, yea his
Stock, of Cash, Goods, Wares, merchandizes and credits in trade on his wife
To have and to hold the said plantation messuage tract and lands, six
hundred and twenty acres, of land to the same more or less, & premises with the
appurtenances, as aforesaid, and all the other goods & chattels, horses, cattle
and effects, unto them the said Jordan Denson & Joseph Denson, their heirs
and assigns, forever. To the only proper use and behoof of them the said Jordan
Denson, and Joseph Denson, their heirs and assigns forever, and the said Hairy
Pope, for himself his heirs, executors, administrators & assigns, the said plan-
tation, tract & parcel of six hundred and twenty acres, of land more or less
and pertaining with all and every of the appurtenances as aforesaid
