*My Indenture* made this twenty first day of October in the year  
of our Lord Christ one thousand seven hundred & seventy seven, Between *Elisha*  
*Williams* of the County of Southamptlon & State of Virginia of the one part,  
and *Sally Williams* of the County and state aforesaid of the other part,  
that the said *Elisha Williams* for and in Consideration of the sum of eighty  
pounds, current money of Virginia, to him in hand paid by the said *Sally*  
*Williams*, the receipt whereof the said *Elisha Williams* with lucky adome  
large, have granted, bargain & sold, aliened & confirmed, by these presents  
doth grant, bargain & sell, aliened & confirm, unto *Sally Williams*, her heirs  
& assigns forever, one seat tract, or parcel of Land, situate lying & being on  
the south side of *Hottoway River*, in the County of Southamptlon aforesaid  
containing by estimation eighty Acres, be the same more or less, known  
as follows. To wit: Beginning at a sapling in a prong of *Thomas's* swamp  
thence along a line of mark & trees, to the head of *Blunts* swamp thence  
down the said swamp to a gum, in *Thomas Edmunds's* line, thence along  
his line to a small pine, a corner of the said *Edmunds's*, *Isaac Poper's*, and  
*William Poper's*, thence along the said *William Poper's* line to a pine standing  
on the side of the great path, thence along the said path to the beginning, and  
also the revenues & revenues, remainder, & remainders, rents & services  
of the said premises, and every part & parcel thereof, and all the estate, right,  
title & interest, claim and demand whatsoever, of the said *Elisha Williams*  
of in and to the said seat, tract or parcel of Land and every part thereof, &  
have and to hold the said seat, tract or parcel of Land, and all and singular  
the premises above mentioned, and every part and parcel thereof unto the  
aforesaid *Sally Williams*, her heirs and assigns forever to  
the only proper use and behoof, of the said *Sally Williams* her heirs and  
assigns forever, and the said *Elisha Williams* for his self and his heirs the  
said seat, tract or parcel of Land, & premises, and every part thereof, against  
himself and his heirs, and against all and every person, or persons whatsoever  
to the said *Sally Williams*, her heirs and assigns, shall and will warrant &  
forever defend, by these presents. In witness whereof, the said *Elisha Williams*
