This Indenture made this eleventh day of May, in the year of our Lord, One thousand seven hundred & ninety two, between Jordan Denson, Joseph Click & Daniel Simmons of the County of Southampton of the one part, and John Davis of the same County of the other part, Whereas the Court of Southampton county, at their Session held in October, 1791, did decree & order that Jordan Denson, John Davis, Joseph Click & Daniel Simmons, or any two of them, should make sale of the two certain tracts of land which John Gardner, deceased & possessed, containing by estimation two hundred and eighteen Acres, more or less, at public Auction, on nine months credit, taking bond, with sufficient security and to make legal conveyance, for the same to the purchaser or purchasers, and whereas the said Jordan Denson, Joseph Click & Daniel Simmons, deceased giving due notice thereof, expose the aforesaid lands, in two separate parcels, to public sale, on nine months credit, and John Davis became the purchaser, of that tract, or parcel thereof, known by the name of his place or the mill place tract, containing by estimation forty seven Acres, more or less, Now This instrument witnesseth, that for and in consideration of the sum and successive of twenty pounds one shilling current money of Virginia, by the said John Davis, to the s^r Jordan Denson, Joseph Click & Daniel Simmons in hand paid, before the unsealing and delivery of these presents, whereof they hereby acknowledge, and themselves therewith fully contented & satisfied, they the s^r Jordan Denson, Joseph Click & Daniel Simmons have quitted, bargained, sold and delivered by these presents do grant, sell, deliver and confirm, unto the s^r John Davis, and to his heirs and assigns forever, the aforesaid tract or parcel of forty seven Acres of land, more or less, called & known by the name of his place, or the mill place tract, situated lying and being in the County of Southampton aforesaid, with all and every the appurtenances thereunto belonging or in any wise appertaining, and the reversionary remainder, & remainders, rents, issues & profits thereof; and all the estate, right, title, interest, claim or demand, of them the s^r Jordan Denson, Joseph Click & Daniel Simmons of and to the same, and every part thereof, to have and to hold the said tract or parcel of forty seven Acres of land, be the same more or less, with the appurtenances aforesaid, unto him the said John Davis his heirs & assigns forever, to the only proper use and behoof of him the s^r John Davis his heirs and assigns forever, And the s^r Jordan Denson, Joseph Click & Daniel Simmons, for themselves, their heirs & assigns the s^r tract or parcel of forty seven Acres of land, more or less, having with the appurtenances aforesaid, unto the s^r John Davis his heirs and assigns forever, against all the right, title, claim or demand,
