

This Indenture made this 22nd day of Feb. 4 in the year of our
 Lord Christ, one thousand seven hundred and thirty ~~four~~ ^{three}. Between
 William Williams the son of John Williams son of the said William
 Gellay his wife of the County of Southampton and parish of Stollway
 of the one part, and Drury Williams of the same County Parish
 of the other part. Witnesseth that the s^d William Williams, John
 Williams Gellay his wife, for and in consideration of the sum of one
 hundred and fifty seven pounds ten shillings, current money of
 Virginia by the said Drury Williams to them in hand
 paid before the sealing and delivery of these presents the
 receipt whereof the said William Williams John Williams
 and Mary his wife do the hereby acknowledge and then
 of acquit discharge the said Drury Williams his heirs for
 ever and themselves therewith fully & utterly contented &
 paid they the said William Williams John Williams &
 Gellay his wife, hath granted bargained, sold, aliened, conveyed, released
 set over, delivered and confirmed by these presents doth grant, bargain, sell
 alien, convey, release, set over, deliver & confirm, unto the said Drury
 Williams, his heirs and assigns, forever, all that plantation or piece
 tract & parcel of Land, situate lying and being in the County of South-
 ampton Parish of Stollway aforesaid containing by estimation two hun-
 dred acres of land, be the same more or less, and being part of a tract
 of land granted to Nathan Williams by Letters patent bearing date 15th
 day of July one thousand seven hundred & forty five hundred as follows
 (to wit) beginning at a cedar tree at a corner tree of the said land standing
 in the s^d Drury Williams's line, at the head of Stollway meadow
 branch, thence the s^d Drury Williams's line to Lion Williams's line
 and the said Lion Williams's line to a cedar tree at a corner tree of said
 line in Titus Fowlers (formerly Theop^r or John Lyness line, thence
 the s^d line to Hickory a corner tree in Lemuel Reeves formerly Theo-
 Lyness line, thence the said line to a pine in the line of the lands
 the aforesaid Drury Williams purchased of Peter Perren, and thence
 the s^d line to Jordan Perren formerly Perren's line, thence the said
 line to the west ~~part~~ ^{part} of the Cypress swamp in Abraham Jenkins's line
 thence down the run of the said swamp, to the mouth of the
 aforesaid Stollway meadow Branch, and up the said branch
 to the beginning — All all the houses, out houses, edifices, buildings
 woods, ways, waters, groats, acres, barrens, meadows
 swamps, gardens, orchards, profits, commodities, hereditaments
