 John Lee of Southampton County Virginia of the other part *Witnesseth*,
 that the said John Darden for and in consideration of the sum of One Hundred
 & Sixty Six pounds fourteen Shillings Current Money of Virginia to him
 in hand paid by the said John Lee before the enrolling and delivery of these
 presents the receipt whereof he the said John Darden doth hereby acknowledge
 and himself to be therewith fully satisfied Contented & paid hath granted bargain
 sold aliened enfeoffed and conveyed and by these presents doth grant bargain
 sell, Alien, Enfeoff, & Convey unto him the said John Lee his heirs & assigns
 forever One Certain Tract or Parcel of Land Containing Two Hundred & Forty Seven
 Acres Being the full Contents of a Patent granted to Jacob Darden of
 Isle of Wight County, bearing date the Twentieth Day of June One Thousand
 Seven Hundred Eighty Three by Excellency William Gooch Esq^r Together
 with the reversions Incursions remainders & Remainders, rents Issues & profits
 thereof. To have & to hold, the said bargain'd premises with the
 Appurtenances and advantages of every kind whatsoever to the said Tract
 belonging, to him the said John Lee his Heirs forever And he the said
 John Darden for himself his Heirs Executors and Administrators will
 Warrant & for ever defend, the said bargain'd premises with the Appurtenan-
 ces against the Lawful Claims of all and every Person or Persons what-
 soever, unto him the said John Lee his Heirs and Assigns forever
 In Witness whereof he the said John Darden hath hereunto set
 his Hand & affixed his Seal this Day Year first above Written
