 for and in consideration of the sum of sixty five Pounds Current Money of Virginia to them
 in hand paid by the said Levi Love in or before the sealing & Delivering of these presents the
 Receipt whereof we the said Benjamin Crumpler & Mary his wife doth hereby acknowledge
 have hath granted bargained sold alien^d release & confirmed & by these presents doth
 grant bargain sell alien release and confirm unto the said Levi Love Hally his wife
 his heirs & assigns forever one certain Tract or Parcel of Land situate and being in
 the County of Southampton Containing one hundred & Eight Acres more or less and
 bounded by the lines of Arthur Byrd John Crumpler Matthew Crumpler Valentine
 Jenkins Alexander Jernaux Daniel Braken & Charles Bailey To have and to
 hold unto the said Levi Love his heirs & assigns forever And also the Remainder &
 remainder Residue & Reversions Rents Issues and Profits of the said Tract or Parcel
 of Land to the only proper use and behoof of him the said Levi Love his heirs and
 assigns forever And the said Benjamin Crumpler & Mary for themselves their
 heirs and assigns with covenant grant and agree to and with the said Levi Love
 that we the said Benjamin Crumpler & Mary his wife doth for quit Claim right
 or title in fee simple of the said Land against all Persons claiming by from or through
 the said Ben^d Crumpler & Mary his wife their heirs & assigns forever In Witness
 whereof We have hereunto set our hands & affixed our Seals this day & date first

 lying and being in the County of Southampton and parish of Mottoway And whereas the
 said Mary cannot conveniently travel to the Court of our said County of Southampton to
 make her acknowledgement of the foregoing hereof we as Justices of the Peace do hereby
 power to receive the acknowledgment which the said Mary shall be willing to make before you
 of the foregoing contained in the said Indenture which is hereto annexed And we as Justices
 here command you that you do personally go to the said Mary and receive the acknowledgments of
 the same and examine her freely and apart from the said Benjamin Crumpler her
 husband whether she doth the same freely and voluntarily without his persuasions or
 threats and whether she be willing the same should be entered in the Court of our said County
