This Indenture made this Twenty Forth day of May in the year of our Lord Christ One Thousand seven hundred and Ninety Nine, between Job Wright of Southampton County Attorney for the State of the one part and James Scott of the County of Virginia State of the other part Witnesseth that the said Job Wright for and in consideration of the just and full sum of Three hundred and thirty four Cents Current Money of Virginia to him in hand paid before the making and delivery of these presents the receipt whereof the said Job Wright doth hereby acknowledge and these of acquit and discharge the said James Scott his heirs and assigns forever and himself herewith fully and entirely satisfied contented and paid hath granted bargained sold aliened released and confirmed and by these presents doth give sell alien release set over and confirm unto the said James Scott his heirs and assigns forever all that Plantation situate lying and being in the County parish and State aforesaid being all the land that now in anywise belongs unto the said Job Wright containing estimation one hundred and fifty Acres be the same more or less and divided according to the known ancient and reputed boundaries and all the houses, outbuildings aspires buildings woods meadows water courses large meadows profits gardens orchards cornfields and lands belonging and all the estate right title interest claim or demand of him the said Job Wright in & to the same and every part thereof To have and to hold the said granted plantation and premises with the appurtenances aforesaid unto him the said James Scott
