Ordered that Master Comr Cobb examine state and settle an account of John Monack's Guardianship with Nathan & Thomas orphans of David Thomas and make report thereof to Court with any matter deemed proper by himself or which may be by the parties to be so stated

The former issued a notice for the parties to attend before him on this day when by John Monack's not appearing application was made to the Court at that October Term for an attachment to bring him before the Court. A writ was granted against him when on the 29th day of November the said Monack and his late ward Nathan & Thomas attended and from the vouchers and accounts exhibited by the said Guardian and admitted by the said Court the following account is formed -
