

This account having been recommended on account of some errors and omissions made by the parties was this day by consent of the parties interested to wit James Mynock and James Mynock Jr. agreed in writing and the Court was instructed to amend to charge the same with his proportions of the estate due from the estate of Maria Mynock to James Mynock Jr. and of the same estate as the parties heretofore charged appears not correct. Accordingly to the written opinion of John B. Mendenhall Esq. in which the Court fully concurs. This opinion is returned by James Mynock Jr. who states that he and James Mynock Jr. could settle it after this account was made. He was \$40. for bond 1827 four months bond for 1828 at the rate of \$160. per annum and six months bond in 1829 at the same rates, which are charges substituted for the two last items charged in the account formerly reported - The Court therefore commences this account on the 31st day of December 1824 taking the balance as stated in the former account, see that report which reports this date as a part of that report -
