In the name of Almighty God amen I David Newson of the County of Southampton and State of Virginia being in firm & legal though diseased mind in no way or sense this my last will and Testament lastly making all other wills or wills verbal or written heretofore made Item 1st I Give in the hands of my wife all my Estate both real and personal for the purpose of paying the debts due by my Estate and providing my Children to be appointed off to them as hereafter provided for. When each one shall become of lawful age or marry then the second share and leguath to my children Sarah Virginia David Roshell and Rebecca all my negroes to be divided equally amongst them each one to receive their portion as they arrive at Lawful age or marry as before directed Item 2nd I Give and leguath to my son Samuel the plantation formerly owned by my father on the north side the River York Item 3rd I Give and leguath to my son David the land and appurtenances on which I now reside and also my half of the mill called Bents Mill Item 4th I Give and leguath to my daughter Rebecca the plantation at persons Church commonly called the Church Plantation Item 5th I Give and leguath to my daughter Virginia and Sarah my two Plantations on Nicholas River commonly called the two-son plantation and the old Quarters to be equally divided between them Item 6th It is my Will that each one shall receive also their respective portion of Land when they arrive at Lawful age or marry Item 7th I Give and leguath to my daughter Rebecca should she before she arrive at Lawful age or marry it is my Will that the plantation allotted to her be given to my son David Item 8th I do constitute and appoint John Person and William Broward Executors of this my last will and Testament. Written and executed this 31st day of January In the year of our Lord one thousand eight hundred and Twenty seven for the County of Southampton I have hereunto affixed my hand and seal.
