Peter North of *St. John North* of *Shelburne County* & *State of Virginia* as man and or woman the my last will and Testament in witness and force following to wit: Item 1st It is my wish and desire that all my just debts be paid. Item 2nd I leave unto my daughter *Peter* one of *Holmes* all my little Estate & the land & plantation whereon I have been continuously in possession from one thousand to fifteen thousand acres more or less here as my negroes till the date of one thousand eight hundred and forty five upon this subject conditions that she the said *Peter Holmes* make no charge for raising and educating the two children *Peter* & *John Holmes* one *John Holmes* Item 3rd I give to my daughter *John North* all papers & all I own that she owns *John North* Item 4th I give and bequeath to *Thames North* son of *John North* one hundred and one acres of land called and known by the name *Decker's tract* & *John* and his heirs forever Item 5th I give and bequeath to *Peter North* son of *John North* one tract of land called and known by the name of *North's ordinary* containing by estimation two hundred acres to be the same more or less to him and his heirs forever Item 6th I give and bequeath to *John North* son of *John North* that I own one tract of land called and known by the name of *Pyrites tract* delin two hundred and fifty acres in back to him and his heirs forever Item 7th I give to *Peter* & *Thames* all papers and things I have a claim have Item 8th I give and bequeath to *John L. North* the land and plantation known and called by the name of *Stearns* containing by estimation two hundred and forty seven acres & hereafter to be the same more or less to him and his heirs forever Item 9th I give to *Peter* & *Thames* being *North* & *John North* Daughters of *John North* one thousand dollars to be equally divided between them to them & their heirs forever Item 10th I give and bequeath *Virginia Holmes* & *Anna Morgan* & *John Morgan* daughters of *George* & *Marion* the sum of thousand dollars to be equally divided between them to them more than his forever Item 11th I give and bequeath *Peter* & *Thames Holmes* the land & plantation whereon I have been upon the conditions that he pay *John Holmes* his brother the sum of five thousand and five hundred when I give and bequeath to the same arising from the plantation & mine to be *North* & *Peter Holmes* during her life to him and his heirs forever Item 12th It is my wish and desire that *Peter* & *Thames* have full & perfect of the said plantation and mine when they have paid his brother *John* the above amount of three thousand five hundred dollars Item 13th It is my wish and desire that if *Peter* & *Thames* should die before the first day of January one thousand eight hundred & forty five then in that case it is my wish and desire that *John Holmes* his brother should have the land and mine upon the same conditions that I have given to *Peter* & *Thames* Item 14th *John Holmes* should die before the said eighth hundred and forty five it is my wish and desire that both their Agents should return back to my Family Item 15th It is my wish & desire that no part of my estate be sold less than hundred and forty five January 1st & then can equal decision to be made of my own good my daughter *Peter* & *Thames* one third during her life one third to *Peter* & *Thames* & one third to *John Holmes* to them and their heirs forever
