Virginia being through the abundant Mercy and Goodness of God weak in body yet of
sound and perfect Mind and memory do make and ordain that to be my last Will and
Testament. In manner and form following. I do hereby recommend my soul to the
Almighty God who gave it and my body to be buried in a Christian like manner to the
direction of my Executors hereafter mentioned and as to what worldly goods it shall please
God to bestow on me while in this life dispose of them in the following manner. First
I do hereby give and bequeath unto my wife Polly Cloud all my Lands and also all my
negroes naming Amy Anthony, Ben a woman and Sarah and all the increase of my
negroes also my stock of all kind my household and Kitchen furniture and all my
plantations in Towns to her during her natural life or widowhood and at her death or Mar-
riage I give unto my son William Cloud the term of Five Shillings to him and his
heirs forever. Secondly I give unto my daughter Charlotte one feather bed and furniture to her
she has now in possession to her and her heirs forever. Thirdly I give and bequeath unto my
daughter Milly Cloud one feather bed and furniture to her and her heirs forever. Fourthly
I give and bequeath unto my daughter Rebecca Cloud one feather bed and furniture to her
and her heirs forever. Fifthly I give and bequeath unto my daughter Mary Cloud
one feather bed and furniture to her and her heirs forever. Sixthly I give unto my son
Philip H. Cloud one feather bed and one mule which I named Helen to him and his
heirs forever. And seventhly I do give and bequeath unto my other three sons
John T. Cloud, James H. Cloud and Ephth Cloud the term of Thirty Shillings each of
Eighty Shillings and bequeath unto my daughter Mary Ann Cloud one feather bed and
furniture to her and her heirs forever. And of my wife Polly Cloud I should get several
again I give and bequeath to her one fourth part of my Estate of which she is now in possession
with my three children above mentioned to her and her heirs forever. And lastly I do give
the property which I have lent unto her to be sold at public Auction and the money
arising therefrom shall be equally divided between my three children namely Charlotte Milly
Rebecca a woman Philip John Mary Ann & Ephth Cloud & their heirs.
