I do give and bequeath unto my beloved Son the Abenighly Head wife gave it me and for my wife good I do give of them out of doors to wit

1st Five and bequeath to my beloved daughter Eliza Raines the money arising from the legacy that James Turner left me by his last Will and Testament to her during her life and at her death for her disposal of it as she thinks proper

2^d I also give and bequeath unto my beloved daughter Eliza Raines all my personal effects more than that I must have in my possession during her life and at her death to dispose of as she thinks proper. In Testimony whereof I do hereunto set my hand and affixation of seal this 26th day July in the third and last year of the reign of our said Majesty King George the fourth and in the sixth year of the said present King
